## **About Us**

Access Clean California, a program administered by GRID Alternatives, connects residents of environmentally and economically disadvantaged communities with benefits like electric vehicles incentives, shared electric bicycles, and no-cost solar power.

Currently in its pilot phase, Access Clean California is streamlining the pathway to clean transportation funding and related benefits by pairing community-based outreach with a seamless, user-centered application experience. Funded by the California Air Resources Board and California Climate Investments, the Access Clean California Pilot Project is laying the groundwork for improved access to all of the state's climate equity programs.

The Latino and Latina Roundtable is a local grassroots organization dedicated to supporting the community and efforts related to political, economic, and social justice. Our mission is to promote civic engagement and a proactive voice in the Latinx community.

### **Position Description and Duties**

We are building a network of trusted community outreach providers to increase awareness of clean mobility and other climate equity programs in the hardest to reach communities. We are seeking a full-time outreach fellow to work with the Latino and Latina Roundtable to implement their outreach strategy around California's clean mobility and climate equity programs. Fellows will receive training and peer mentorship from Access Clean California with on-site supervision from the Latino and Latina Roundtable staff. We are looking for individuals who are passionate about improving outcomes in the communities they serve and also are committed to learning about environmental justice and access through an equity framework.

- Promote community awareness of Access Clean California clean transportation programs, clean mobility, and mobility justice
- Organize virtual and/or safe in-person outreach and education events around clean mobility programs
- Coordinate with outreach campaigns led by other community outreach providers and Air Resource Board programs

- Flexibility and willingness to embrace change and bring ideas and energy to a rapidly evolving organization
- Interest and enthusiasm for renewable energy, community development, helping families and communities in need
- To be eligible for AmeriCorps, applicants must be a U.S. citizen, national, or legal permanent resident of the United States.
- You must be 18 or older.
- Desire to work as part of a team with the goal of improving outcomes for this community.
- Preference for individuals who are bilingual since this will aid in better serving the target population.

This position is based out of Pomona, CA and **will be remote until further notice**. Travel may be required to enter the office to pick up office equipment.
